



Golf Maine Park District CAMP CHILD CARE 2009 Information

Before and after camp child care is offered to complement summer day camp at Dee Park for children entering kindergarten through sixth grade. Children receive quality care in a safe, clean environment and are supervised by trained and conscientious staff. Children are kept active in games and activities prior to and after the day camp program. Parents may enroll their child/children for all eight weeks or by the session. The minimum registration period is one 2-week session.

Session I:	June 22 – July 2
Session II:	July 6 - July 17 *No camp July 3rd
Session III:	July 20 - July 31
Session IV:	August 3-August 14

TIMES and FEES:

Before Camp Child Care:	7:30 am - 9:30 am	\$52.00 per two week session
After Camp Child Care:	3:30 pm - 6:00 pm	\$64.00 per two week session (includes snack)
Both Morning & Afternoon:		\$116.00 per two week session

TLC-Friday Child Care: \$7.50/day for AM (7:30-9:30am) & \$9.25/day for PM (3:30-6:00pm)

Payment for each session is due in advance on Friday before the next session starts.

DROP OFF AND PICK UP PROCEDURES

You are responsible for ensuring that your child gets to the program and is placed in the care of our staff every day. If your child is going to be absent, please let our staff/office know in advance so we know not to expect them. For your child's protection, he/she must be signed out each day. Children will only be released to you or other authorized persons designated by you on the registration form. Changes to your pick-up authorization list must be done in person and/or in writing at the Dee Park office. For your child's protection, **VERBAL CHANGES ARE NOT PERMITTED.** Authorized individuals picking up children that are not recognized by us will be asked to show photo *identification*.

Late Pick-Up. If you are late picking up your child, you will be charged a late fee.

BEHAVIOR and DISCIPLINE

Children are entitled to a safe, pleasant and harmonious environment. Participants are expected to show respect to staff, other participants and the property of others; refrain from using foul/abusive language; and threatening or causing harm to others. A firm, positive approach will be used regarding discipline. The District reserves the right to dismiss a participant from the program if his/her behavior is detrimental to others.
